

## Who Is Eligible For Services?

An individual is eligible for HCS services if he or she:

- Meets the Primary Diagnosis of Mental Retardation and participates in the local MRA
- Is eligible for Supplemental Security Income (SSI) benefits
- Is eligible for Medicaid
- Must have an authorized Individual Plan of Care (IPC)



## What's the Enrollment Process?

- An applicant may enroll through his or her local MRA for HCS Services
- An applicant may also change existing HCS providers by completing the HCS Transfer Process
