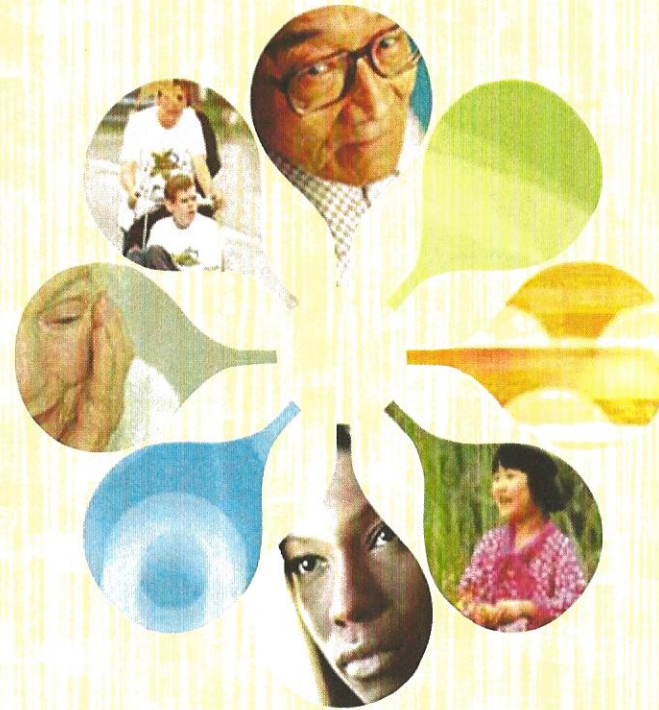

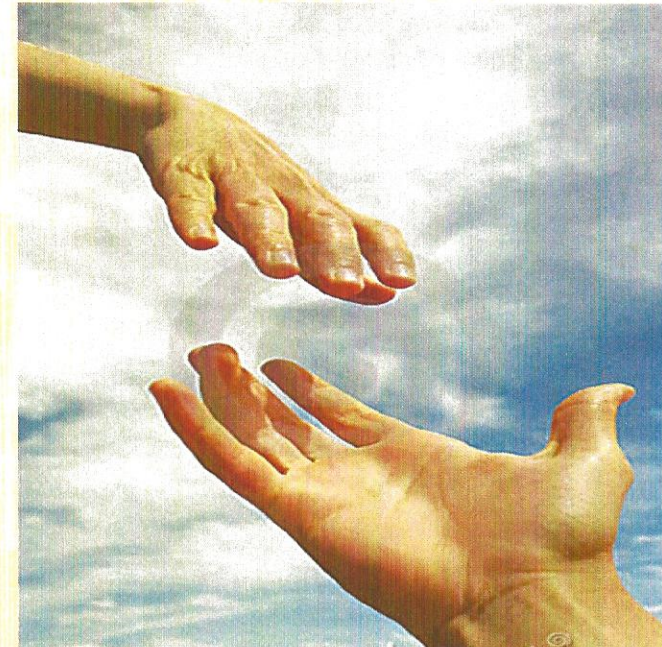

Services are available to persons living in their own homes and living with their family, or paid companion. Services may also be provided to persons living in small group homes where no more than three persons may live.

When a person is offered HCS services, the Mental Retardation Local Authority will assist the person with completing the HCS program enrollment.
