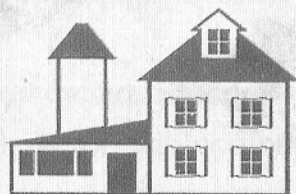

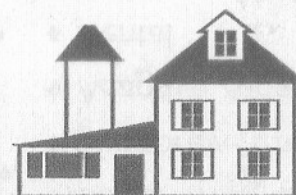

5. Individual must have approved Individual Plan of Care which cost does not exceed 125% of the annual ICF/MR rate paid to a small ICF/MR facility.
