- ⊛ To provide forum for social integration with peers and other population in the community

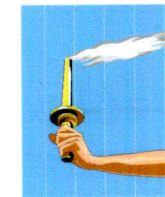
- ⊛ To identify and pursue opportunities to improve all systems and procedures that impact upon consumer care, service and satisfaction
